**“All good things come in threes”: rendimax raises its interest rates.  
New 24-month time deposit with an annual pre-tax yield of 4%.**

Rendimax confirms itself the online deposit with the best offer in its category.

On Monday May 30<sup>th</sup>, 2011 Banca IFIS will raise the interest rates, for the third time in a row, on its rendimax deposit account acknowledge promptly and on time to all clients the increase in interest rates occurred in the market. New interest rates will be applied on new time deposits to all customers, old and new.

The rendimax interest rates, applied on free deposits, will stay at an annual, gross rate of 2.30%.

Moreover, all customers will have a chance to obtain even higher yields by tying up all or part of their capital even for a 24-month period, with a truly fantastic return: 4,00%.

This latest innovation joins a wide offer that, in terms of time deposits, starts from 1 month all the way up to 24 months and, in terms of nominal interest rates, goes from 2.45% up to 4.0%. Interests accrued on the tied up capital will continue to be credited in advance directly on the rendimax free account.

Another factor that renders Rendimax different is that, in addition to there being no opening/activation fee or management fee, the stamp duty is paid by the Bank and therefore the client has no such fees to pay. Furthermore, the Rendimax investor also has the exclusive Rendimax Payment Card available to him/her (usable on the Bancomat/Pagobancomat and Cirrus/Maestro circuits).*
