(*) INFORMATION PURSUANT TO ART. 13 OF ITALIAN LEGISLATIVE DECREE NO. 196 OF 30 JUNE 2003 ON THE PROCESSING OF PERSONAL DATA

Banca IFIS (hereinafter also referred to as the Bank), Owner of the Data Processing, pursuant to art. 13 of Italian Legislative Decree 196/2003 (hereinafter the Code) informs you that the Personal Data provided by you in any way will be processed in a fair, lawful and transparent manner, respecting the right to privacy of each individual, and only for the purpose of allowing the Company to manage the Shareholders' Meeting and the consequent legal fulfilments.

The Personal Data is processed by Banca IFIS with manual, computer and/or telematic instruments, with logics strictly related to the aforementioned purposes, in order to guarantee the security of the Data and the right to privacy of the interested party, and in any event in compliance with the provisions of Italian Legislative Decree 196/2003.

The law (art. 7 of Italian Legislative Decree 196/2003) entitles the interested party the right to know which personal data the Owner has, other subjects to which this information has been communicated and how they process it, how the data is being used, as well as the right to have this data deleted, transformed in anonymous form or blocked in case the processing is carried out in violation of the law, the right to ask for this information to be updated, corrected or integrated, or the right to object to the processing of this data. The interested party may nevertheless object at any time to the processing aimed at the sending of commercial and/or advertising material, at direct sales and/or for market research purposes. Costs and expenses for the shipping, duplication and/or release of any information requested by the interested party shall be charged to the latter's account.
