Young athletes

For more than three years, Banca Ifis has **supported medal-winning junior athletes from CONI** through the awarding of scholarships. Similar initiatives have also been launched in collaboration with U.C. Sampdoria and Luiss SSD, all aimed at assisting young athletes in both their educational and sporting development.

Completing these efforts is the ‘**Social Impact Measurement Model**’, a tool developed by the Bank in partnership with the **Polytechnic University of Milan**. This model enables the measurement of the positive outcomes generated by these projects.

Financial solutions for the operators of the sports ecosystem

Liquidity management solutions

Factoring or credit advances are versatile financial products that can be applied in various contexts. Within the sports sector, these solutions are tailored to the specific needs and characteristics of sports clubs. Below are some examples of their application:

TV rights

For companies working with public or private broadcasters, a factoring contract enables the assignment of receivables from TV rights (if managed directly), or the advance payment of contracts agreed with the leagues.

Sponsor partnerships

Commercial partnerships with sponsors are a fundamental element in the sporting world. The advance payment of contracts and the assignment of receivables—either from sponsors directly or via the leagues—are effective solutions for optimising a sports club's cash flow.

Sports Medicine

For companies operating a dedicated sports medical centre, it is possible to assign receivables arising from insurance premium claims.

Buying and selling of players

Receivables arising from the direct sale or purchase of players can be assigned, provided they involve foreign clubs. For transactions within the domestic market, receivables may be mobilised based on the balances certified by the league.

Additionally, for companies with ongoing supplier relationships and significant purchasing volumes, **reverse factoring** can be a useful solution for managing trade relations and streamlining payment processes.

Equipment leasing

Companies can benefit from leasing for equipment used in stadiums, sports halls, or for medical devices in sports medicine facilities.

Flexibility and financial guarantees

Clubs can take advantage of flexible cash management through *Ifis Impresa Conto Corrente*, allowing for greater control over expenses. Additionally, if the league demands a guarantee for investments during player transactions, sports clubs may ask for a guarantee to ensure protection for all parties.
